Community Expression:

 Kathleen has a concern about the redwood tree in the back of the downtown park. Amber said that we could have an arborist take a look at it. Don mentioned that could contribute to drawing down the water.

Manager's Report:

RIRE Grant application status.
 Michael submitted the application, waiting to hear back. This grant is project based.

2. Report:

- a. Groundskeeper will not be able to come out every day now that he has gotten another job. Michael to touch base with him.
- b. Seeing uptick in use at both parks. Someone set a fire in the Mesa Park restroom.
- c. Toby spoke to Lunny about providing paving bid.
- d. Sign was taken apart by skate park and is being disposed of.
- e. Downtown park still needs to be re-seeded.

Downtown Park:

- 1. Proposed public shower Don Smith worked up some more detailed drawings and spoke to the County. 6x6 size and merging with the roofline. Now funding is the main issue. Don contacted someone that had come out from Health & Human Services in a Rodoni town hall that has some funds allocated for these types of projects. Don would also like to put in a request to be added to the RIRE grant if we are chosen to submit a formal grant application.
- 2. Condition of downtown park.
 Michael reported that it is looking alright, but the bathrooms have been a problem. Irrigation system is working just fine.
- 3. Discuss possible re-design of park. Michael has not heard back from landscape designer, he will follow up.

Mesa Park:

- 1. Consideration of request for multiday parking at Mesa Park. Michael got a request for use of the park May 1 3 for a three day event. There are 40-50 spots in the front. But there are events on Sunday that require at least 20 spots. The back holds approx. 200 spots. Motorcycle club would need to be notified ahead of time. Charles will assist with the logistics during that weekend. \$500 suggested donation per day.
- 2. Condition of Mesa Park. Toby had a thought of rototilling the capeweed or using plywood. Michael will continue to work at it.
